Be sure to read this privacy notice before providing your personal data. If you do not agree, you must not provide any personal data. If you provide your personal data, your consent will be tacitly understood, according to this notice.

Clinical Research PS Mexico, S.A. de C.V. is a Mexican company, with headquarters located at 2974 Diagonal Golfo de Cortés, Vallarta Norte, Guadalajara, Jalisco, C.P. 44690 (hereinafter "**DROX**").

DROX is responsible for the use and protection of your personal data, in that sense and in accordance with the legal obligations established in Mexican legislation, through this, the owners are informed of the data that we collect and its purpose.

The Purpose:

DROX only obtains the personal data of its owners, either because it has a legal and/or commercial relationship with the holder, or because it could potentially have one. Personal data may be collected through electronic, optical, sound, visual means, or by any other technology or other sources that are permitted by Mexican law, in order to establish an academic, legal and/or commercial relationship.

DROX will only collect personal data that serves the purpose of establishing a first contact with the Holder, such as "name", "mail", "telephone" and all information that the Holder may share in the "Message" section and/or by email.

Personal Data may be collected when:

Access, Rectification, Cancellation and Opposition Rights:

Likewise, you have the right at all times to request **access** to said information, **rectification** of your data in case they are outdated, or inaccurate or that the information is incomplete, **cancellation** so that said information is eliminated from our database, and/or right of **opposition**, that is, oppose the use of your personal data for the specific purposes indicated in this document.
